Starting April 2023, the U.S. Army Corps of Engineers and the Federal Emergency Management Agency are launching the next phase of stakeholder engagement for the National Levee Safety Program to seek feedback on draft products and options including:

- Sample content from the National Levee Safety Guidelines
- » Outline for a new management guide to help users understand and carry out responsibilities for operating and maintaining a levee from the time it is constructed through its useful life
- » Example templates to help with developing an operation and maintenance manual and emergency action plan
- » A new cost brochure to help users understand, at a high-level, ranges of costs for common levee-related activities
- » Activities that states can implement as part of a levee safety program
- » Updates to the National Levee Database including new public facing webpage and a customizable dashboard to help states manage data for their levee portfolios
