## **Usage Rights for Government Furnished Information**

Prior to being given access, each individual shall sign this agreement.

I shall return the data and documents and any additional copies that I may have produced, regardless of whether they are electronic or hard copy format, when the data and documents are no longer required.

If I violate the terms and conditions of this agreement, I understand that the unauthorized disclosure of sensitive but unclassified information could compromise the security of the United States and the project.

If I violate the terms and conditions of this agreement, such violation may result in the cancellation of my access to sensitive but unclassified information. Furthermore, if I violate the terms and conditions of this agreement, the United States may institute a civil action for damages or any other appropriate relief. The willful disclosure of information that I have agreed under the terms of this agreement not to divulge may constitute a ciminal offense.

Data and documents provided in accordance with this agreement continue to be the records of the <<u>District</u> Name>, Corps of Engineers, and shall not be released by <u>AGENCY NAME</u> under the Freedom of Information Act, or any other state access to information law.
